### Scholarships and support schemes for CROUS scholarship students • Start of the 2026 academic year

NEOMA is committed to equal opportunities. Students receiving a CROUS grant are eligible for a partial or full waiver of tuition fees, depending on their income bracket and year of study.

In addition to covering or reducing tuition fees, NEOMA Business School, through its Wellness service, offers a comprehensive support ecosystem designed to safeguard the academic journey of grant-funded students: mentoring with our partners such as Article 1, administrative support, and monitoring of student life.

**Student loans:** NEOMA Business School has established partnerships with several banks, enabling you to secure loans at preferential rates. Depending on your needs and circumstances, our partners will select the best options to help you realise your plans!

These exemptions apply upon presentation of a valid final grant notification from the CROUS for the relevant academic year.

#### HOW TO APPLY FOR YOUR CROUS GRANT

##### January to May 2026

- I check my eligibility using the CROUS grants simulator:

- I am completing my Student Social File (DSE).



Remember to apply for the CROUS grant every year, to renew your DSE, and to submit all the required supporting documents by the deadline.

##### May 31, 2026

- The Crous will send you a provisional notification, which you must then upload to:

##### October 2026

- I have received confirmation of my grade allocation and of my exemption from tuition fees.

##### During the academic year

- I keep track of deadlines and update my status if anything changes.

#### EXCELLENCE SCHOLARSHIP PREPARATORY CLASSES

Because excellence deserves to be rewarded, NEOMA awards an Excellence Scholarship to the top candidates from preparatory classes.



##### Who is eligible?

The top 30 students from economics and business preparatory classes (ECG and ECT) and the top 30 students from other preparatory classes.



##### How much is it?

A discount equivalent to 25% of the tuition fees for the first year of NEOMA's Grande École Programme.



##### How can I apply?

No action is required: eligible candidates are automatically identified and contacted by NEOMA's Admissions Office.



**To remember:** By combining your CROUS grant, the fee waiver provided by NEOMA and, where applicable, the Excellence Scholarship, your studies on the Grande École Programme can become more affordable.
